## ORDINANCE NO. 551-14-01

AN ORDINANCE OF THE BOROUGH OF MANOR, WESTMORELAND COUNTY, PENNSYLVANIA, AMENDING CHAPTER XVI OF THE CODE OF ORDINANCES OF THE BOROUGH OF MANOR, AS PREVIOUSLY AMENDED AND SUPPLEMENTED, SETTING PROHIBITIONS ON PARKING ON VARIOUS CUL-DE-SACS ON STREETS IN THE BOROUGH; AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, the Borough Council of the Borough of Manor has determined that for public safety and proper maintenance purposes parking of vehicles should be prohibited on the cul-de-sacs of various streets in the Borough.

**BE IT ORDAINED AND ENACTED**, and it is hereby ordained and enacted by the Borough Council of the Borough of Manor, Westmoreland County, Pennsylvania as follows:

**SECTION I:** Part 3 of Chapter XVI of the Code of Ordinances of the Borough of Manor, as previously amended and supplemented, is hereby amended and supplemented to provide as follows:

## **SECTION 33.**

\* \* \*

B. <u>Parking is prohibited at all times on the cul-de-sacs of the following highways and streets.</u>

On the highways and streets, or parts of highways and streets as hereafter set forth and by authority granted by the Borough Code and the Vehicle Code, it shall be unlawful for any person or persons to park any vehicle or combination of vehicle and any attached vehicle or trailer in the areas prescribed below:

C. Penalties. Any person who violates any of the provisions of Section 33 of Part 3 of Chapter XVI of the Code of Ordinances of the Borough of Manor shall, upon conviction, be sentenced to pay a fine of not more than TWENTY-FIVE \$25.00) DOLLARS, plus costs, expenses and other sums incurred by the Borough in the prosecution of such event; provided, however, that any person who violates Section 33 may avoid such proceedings and a fine of TWENTY-FIVE (\$25.00) DOLLARS, plus costs, expenses and other sums incurred by the Borough in the prosecution of such offense, if, such person pays, within forty-eight (48) hours of the time and date of the violation, as indicated on the ticket issued with regard to such violation, the sum of TWENTY (\$20.00) DOLLARS.

**SECTION II**: All provisions of Chapter XVI of the Code of Ordinances of the Borough of Manor as previously amended and supplemented which are not inconsistent with this Ordinance remain in full force and effect.

SECTION III: If any word, phrase, section, sentence, clause or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, invalidity or illegality shall not affect or impair any of the remaining words, phrases, sections, sentences, clauses or parts of this Ordinance. It is hereby declared to be the intent of the Borough Council that this Ordinance would have been adopted had such unconstitutional, illegal or invalid word, phrase, section, sentence, clause or part thereof not been included therein.

**SECTION IV:** General Repealer. Any ordinance or parts of ordinances in conflict with this Ordinance are hereby specifically repealed.
